QUESTIONS

Where do we park? YMCA Craft Fair vendors may park in one of three locations: in the parking lot just outside the Community Center (there are over 200 parking spots); in the adjacent Blacksburg Aquatic Center parking lot; or in the old high school parking lot located across the street and beyond a track (vehicles with trailers must park here).

When and where will we unload? On Friday morning, November 10, unloading will occur at one of three building entrance points, dependent on your booth location. Two points lead right into the event room, and one is just an indoor ramp away from the event room. Many carts and volunteers, mostly VT students, will be on hand to assist you with unloading!
